N.B.:

- (i) The Provisional Merit List has been prepared by considering the data delectread by the candidates.
- (ii) * The rank has been assigned to those candidates who appeared in the Higher Secondary (10+2) or equivalent examination, where 200 was the full marks of individual subject(s). The percentage value of marks has been considered for the preparation of the provisional merit list.
- (iii) During document verification if, at any stage, it is found that an applicant is ineligible as per prescribed eligibility norms, his/her candidature will stand cancelled, even if his/her name is in the provisional merit list, or seat is allotted to him/her, or takes admission and gets registered.

Tie-breaking Method:

The tie shall be broken up by marks in Chemistry if still tie, then Physics and if still tie, then Mathematics or Biology (which is higher) and if still a tie then higher age would incur higher merit position.
